 one. Direct each financial institution to forward the completed form,
 along with the payment, to the pension plan.
- Transfers can take up to eight weeks. Ensure you take this
 form to your financial institution with sufficient time to meet the
 payment due date. Payments received after the due date will not
 be accepted.
- Advise your financial institution which funds to transfer. Failure to do so may cause a delay in processing and may result in you having to re-apply to purchase service.
- Ensure that your financial institution deducts service fees before transferring the exact amount.
